Dear Sirs:

We are very concerned for the safety of **Héctor Sánchez**, union leader from the Oil Workers' Trade Union (USO) in the city of Puerto Gaitan in Meta Department. On July 16, a death threat was left at his home. It read, "our condolences for the loss of your wife and son, do not leave [your son] without a father and widow or do not become a widower."

On July 13 and 14, Héctor Sánchez. had been organizing meetings and participated as a witness in an "Oil Hearing" at which trade unionists, indigenous people and peasant farmers spoke about human rights abuses arising from the extractive industry. This meeting is to be followed in August by a mock trial of oil companies.

On July 20, laptop and desktop computers and audio and video recordings were stolen from the office in Bogotá of the NGO Network of Brotherhood and Solidarity with Colombia (REDHER). Money was not taken from a drawer that the intruders searched. REDHER, one of the supporters of preparations for the mock trial, had been documenting the hearing in Puerto Gaitan. The websites of REDHER, Political Prisoners Solidarity Committee (CSPP) and other organizations supporting the mock trial were hacked.

USO trade unionists have been repeatedly threatened and have been the victims of extrajudicial executions and enforced disappearances, committed by paramilitary forces, at times acting in collusion with the security forces. In December 2012 USO leader Milton Parra was assassinated the day he received a death threat (cf our letter of Dec 11 2012).

## We therefore **strongly urge** that you

- provide protection for those threatened, as described above, according to their wishes;
- order a full and impartial investigation into the death threat against Héctor Sánchez and his family and the theft at the office of REDHER, publish the results and bring those responsible to justice.
